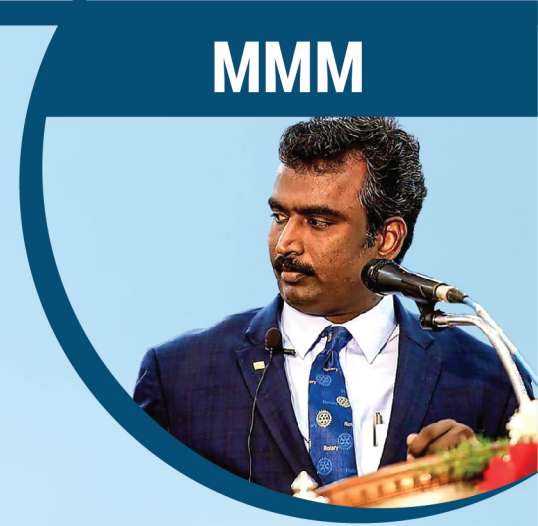

- His journey in his 25 + years since 1992 and his commitment towards Social & Economic upliftment of the masses of the society at large has been an inspiration on all fronts.
- His passion for youth service activities have made him address more than 500 gatherings crowned with YOUTH in and around Tamilnadu, by ways of Training Seminars & Leadership Programs.
- His Non-Profit Charitable Trust called 'THE EXCEL FOUNDATION' channelizes the CSR (Corporate Social Responsibility) contribution from his own company for the benefit of Humanity, mainly the younger generation, executing service programmes to tackle the issues of hunger, health, education and overall development of the youth, school children and orphans. The Trust involves in socio-economic programmes like adopting a Spastic Children home, supporting evening coaching centres, helping mentally challenged children, physically handicapped boys, accident victims and providing educational scholarships.
- He is also the functioning Governing Board Member of the Spastic Society of Tiruchirapalli which manages 5 spastic children service centres.

Rotary

Muruganandam Joined Rotary as a Rotaractor at the age of 16 and became a Youth Leader as DRR (District Rotaract Representative). He was awarded 'One of the **Outstanding DRR in the world**' by Rotary International, USA. He went on to start the Rotary Club of BHEL CITY Tiruchirapalli in 2009. During his President ship, he bagged 10 Awards, including Best President & Best Club.

An active Rotarian, he was the Rotary District Governor (2016-17) for the Rotary International District 3000 spanning **Trichy, Karur, Ariyalur, Perambalur, Thuraiyur, Pudukkottai, Manapparai, Dindigul, Theni, Kodaikanal and Madurai**. He was one of the youngest ever Rotarian to have served as Rotary District Governor.

His tenure also witnessed 12 Guinness World Record Official Attempts out of which 8 were award Guinness World Records. The aim was to create awareness in more than 1 million people on social causes like Literacy, Organ Donation, Blood Donation, Eye Donation, Women Empowerment and Empathy towards Challenged People and Transgenders. The Record attempts involved and motivated more than 2,00,000 youth.

His Governorship tenure turned out to be a Golden year of Records. He was the only Rotary Governor in India (out of 40 Governors) to win awards on all the three fronts of Rotary - **Membership Development, Fund Collection & contribution** to the Rotary Foundation (\$1.075 – 7.2 Crore rupees) and **Public Image**.

In his 27 + Years in Social Life, he has won the hearts of the society at large through numerous service projects with large number of beneficiaries.

Awards & Recognitions

- He was awarded with **Rotary International's highest honour - "Service Above Self"** award in 2018-19.
- He is one among a very few people in this part India, who received Rotary Internatioal's '**Vocational Service Leadership Award**'.
- Other awards include "**Youth Icon**" Award from Dhanalakshmi Srinivasan Group, "**Life Time Achievements Award**" from a Non-Governmental Organization "Thiesaiyal" in community service, Tamilnadu.
- He is one of the very few in India to become an Arch Klumph Society Member in Rotary (Contribution of USD 2,50,000).
- A philanthropist by nature, his personal contribution to the Rotary Foundation stands at \$ 3.10 Lakhs (Rs.2.17 crores) . This is apart from his contributions towards the society at large through projects done by his "The Excel Foundation", CSR wing of Excel Group.

He is married to Ms.Sumathy and has a daughter Priyadharshini pursuing First year MBBS at Omandurar Governement, Chennai and a son Praveen Karthik, doing schooling.
